# 5.1 Transforming Tate Modern Update

a. It was reported that the project is working to time and budget. Trustees' attention was drawn to the funding provided by the London Development Agency on 10 March 2010 in support of the Bankside Urban Forest scheme.

## 5.2 Tate and National Portrait Gallery Storage Agreement

a. It was noted that the agreement had grown out of discussions with the National Portrait Gallery regarding the National Art Collections Centre (NACC), was strongly supported by the DCMS, and is an example of Tate working in collaboration with colleagues in the sector to mutual benefit.

a. It was noted that Tate had received confirmation of the Grant in Aid allocation for the 2010-11 financial year. It was also reported there is one outstanding issue and it was noted there is high level confidence there would be a satisfactory resolution.

It was also noted that Tate awaits confirmation of two further Trustee recommendations, both of which are currently before the Minister. The Chairman thanked those Trustees who had been involved in the interview processes. It was reported that the appointment processes had yielded a number of candidates who are also able to contribute to Tate in other ways, for example through membership on the Board councils and committees.

## 5.10 Tate / National Gallery Update

a. It was noted that a short meeting with the Directors of Tate and the National Gallery, and the two liaison Trustees, would be arranged to discuss how the two galleries might work more closely together to their mutual advantage.

a. Trustees' attention was drawn to the dinner and away day meeting on 18 and 19 May, and the dinner planned for 13 July.

#### 5.12 Trustees' Visit to Tate St Ives, 8 and 9 October 2010

a. It was highlighted that there is an opportunity to visit Tate St Ives in October, and that it is hoped that Trustees will be able to attend. It was noted that Trustees would be able to attend the Tate St Ives Council meeting followed by the opening for the Peter Lanyon exhibition, which is being curated by Chris Stephens.

It was reported that a start date will be confirmed, but is expected to be in mid-May. It was also noted that Vicente Todolí had decided to leave Tate. It was agreed that he had added a tremendous amount to Tate Modern, in particular with regard to early 20<sup>th</sup> century exhibitions and building the supporter base for the gallery in the UK and abroad. It was noted that the new Director of Tate Modern, when appointed, would have the opportunity to help shape the programme of the expanded Tate Modern. Trustees were updated on the process to appoint Vicente's replacement. Trustees were also updated on the process to appoint a Chief Executive of Tate Enterprises. It was noted that an appointment panel for the position would be convened after Easter.

AGREED to delegate the letting of the substructure package to the TTM project board, subject to it being deliverable within budget and to it being ratified at the Board of Trustees meeting in May.

The meeting was adjourned for a short break.

Franck Petitgas left the meeting. Rebecca Williams, Alex Beard, Nicholas Serota, Vicente Todolí, Caroline Collier, Sue Cambridge, and Judith Nesbitt joined the meeting. Items 9 and 10 were considered ahead of item 8 on the agenda.

# 8. Tate Development Campaign

a. The Director of Development summarised the report. It was highlighted that the agreed objectives had been successfully met with regard to revenue and acquisition funding streams and, though capital fundraising had been challenging

in light of the circumstances discussed previously, the next year would be important. It was reported that, with regard to gifts to the Collection, a significant number of commitments had come to fruition and that an update on the campaign would be prepared for Trustees. It was noted that messages on the growth of the Collection should be included in the communications relating to the Transforming Tate Modern project. The organisational structure of fundraising within Tate was discussed, as was the need to continually renew and refresh the groups that contribute to Tate's fundraising efforts.

#### b. The Trustees

CONFIRMED their approval of the development strategy.

Rebecca Williams left the meeting.

## 9. Finance Report

a. The Director of Finance reported that Tate is on track to meet expectations in admission income and it is expected there will be a balanced budget in the current financial year. It was also noted that Tate had received further capital funds from DCMS in the current year. The Chair of the Finance and Operations committee reported on progress made by Tate during the year around cost control and the management of potential cost overruns.

## 10. Transforming Tate Britain Phase 1: Stage E

a. The Deputy Director updated Trustees on the Transforming Tate Britain (TTB) project. It was noted that detailed design had concluded and that the planning application was ready for submission. Trustees were updated on project fundraising. *Information has been exempted under Section 43 (2) of the Freedom of Information Act 2000*<sup>3</sup> It was also noted that approval of the funds requested would take the design work up to July 2010, at which point Trustees would discuss further project implementation.

#### b. The Trustees

APPROVED the submission of the Planning Application and Listed Building Consent; and

APPROVED the budget expenditure as outlined in the report to enable the project team to complete Stage E by July 2010.

#### 11. Sustainability Strategy Progress Report

a. Judith Nesbitt introduced the report. Progress since September 2008, when the topic was last discussed by Trustees, was reported. It was highlighted that Tate's advancement in the area had been noted by funding bodies and peers in the sector. *Information has been exempted under Section 22 of the Freedom of Information*

Act 2000 <sup>4</sup> It was agreed that the reporting of business travel would be addressed in the short term. It was agreed that carbon emissions would form part of Tate's annual reporting in the future. Trustees expressed their support for sharing Tate's progress and experience more widely, including with the public and audiences. The Trustees commended the team on the very good progress achieved in a short period of time.

Claire Eva and John Stack joined the meeting.

## 12. Tate Audience Strategy Update

a. Claire Eva introduced the discussion. It was highlighted that progress had been made across working methods, data capture and market research. The Chris Ofili exhibition campaign was presented as an example, and a range of efforts intended to raise awareness among young people were detailed. It was noted that campaigns such as this sit along side Tate's long term work with community partners. Trustees commented on the strategy and progress, and thanked the team for their continued hard work in this important area. It was agreed that the topic would be reviewed again in one year, allowing time for the incoming Director of Media and Audiences to influence the work.

## 13. Tate Online Strategy 2010–12

- a. John Stack presented the strategy for Tate online. It was highlighted that the new designs would allow users to more easily find what they seek; dynamically relate areas of content to one another; enhance opportunities for audience participation, discussion and distribution; and allow users to find and access Tate content 'where they are,' including via mobile technology. Trustees discussed copyright. It was reported that Tate is in discussion with copyright agencies regarding the developments envisioned. It was also noted that it is important that online discussions are focussed intellectually, such that they are valuable to visitors. It was agreed that the development of curators' voices online and 'Tate presents' partnerships with external experts could contribute constructively to this.
- b. Progress on the site architecture and transition plans were summarised, as was the projected timeline for implementation. Trustees queried the implementation timeline and in particular various related areas of such as integrated customer relationship management and sales capabilities. It was agreed that an integrated implementation map would be prepared for the May Board of Trustees meeting, bringing together the online strategy and IS strategy implementation plans, and clarifying the shortest possible timeline for implementation of the various integrated aspects of the online, CRM and sales areas. The Trustees thanked the online team for the very good report.

# 17. Collection Strategy

It was also noted that Tate does seek to be selective in its acquisition of works on paper, for example in cases where print making forms an important part of an artist's oeuvre. Trustees discussed the geographic scope of Tate's collecting. It was highlighted that the support of acquisition committees and partnerships with advisors are important ways Tate strengthens its capacity and knowledge.
