It was noted that a range of solutions were being tested that it was expected a solution would be achieved within existing contingency provisions. It was reported that EDF had agreed to the terms offered by Tate in relation to the easements, and that this would not affect the hand-over date for the site. Trustees granted authority to the Deputy Director to execute the agreement. # 5.2 Visitor Services Contract Changes

a. Trustees were informed that the proposals outlined by the Director of Visitor Services and Estates at the September Board of Trustees meeting had been shared with unions and, following a period of consultation, are likely to be confirmed in January 2010.

# 5.3 Pop Life Review

It was reported that the Nominations Committee had confirmed the Trustee roles to be advertised in early 2010 and had reviewed appointments to the Board's other councils and committees, which would be reported to the Board in January 2010.

a. It was reported that the keynote speaker had confirmed his attendance at the conference in the afternoon.

## 5.8 Staff

a. It was noted that Celia Clear would retire after sixteen years as the Chief Executive of Tate Enterprises in the spring 2010. Trustees commented on the exceptional development of Tate's publishing activities under her leadership. Trustees were informed that the process to recruit a new Chief Executive of Tate Enterprises would begin, as would the process to appoint a successor to the Director of Tate Media. It was also noted that Dr Penelope Curtis who had been appointed Director of Tate Britain would take up her position in April 2010, and would join the Trustees meeting following the break.

It was noted that a review is underway with the regional gallery directors and will be completed in March. Challenges in securing local and regional funding support were discussed. It was agreed that a discussion item on Tate Liverpool would be brought to the Board within the next six months.
- b. The Director of Finance reported that the forecast had improved in part due to positive developments relating to utility price forecasts and autumn exhibition visits. Trustees were also updated on recent discussions with the DCMS.

Sue Cambridge left the meeting. Will Gompertz joined the meeting.

## 8 Tate Brand

a. The Director of Tate Media presented recent work on the Tate brand. Trustees discussed the role of national and international partnerships. It was noted that there was consensus around the concepts underpinning the brand personality, but that the words used to describe these would be refined. Trustees commented that the brand architecture had moved forward since the last discussion. It was agreed that the presentation to be given at the Family Conference on 1 December 2009 would be shared beforehand with Trustees. It was also agreed that further input would be sought from staff and that Trustees would be updated on the results of the next phase of work, including the visual representation, in the first half of 2010.

Dr Penelope Curtis joined the meeting. Trustees welcomed Dr Curtis and congratulated her on her appointment as Director of Tate Britain.

## 10.2 Tate Britain Programme 2010 – 2012

- a. Judith Nesbitt, Chief Curator of Tate Britain, presented plans for the Tate Britain transitional programme to 2012. It was noted that the programme is increasingly experimental, responding to new ideas and seeking to address the complexity and diversity of Britain in the 21<sup>st</sup> Century. It was highlighted that the programme rhythm had been altered, and that these changes would begin to be implemented in 2010.
- b. The exhibition concepts for each season were presented. In response to a query, it was reported that the audience strategy for Tate Britain is being developed in close collaboration with curatorial staff and will influence the planning, development and presentation of the programme.

## 11 Transforming Tate Modern: A Programme Vision

 a. #### 19 Any Other Business

- a. It was noted that Tate would lose two key members of staff in January 2010. Trustees' attention was drawn to the significant advances made by Tate Media under the leadership of Will Gompertz over the past seven years, including initiatives such as Tate Online, TateShots and the Long Weekend. Trustees complimented Will Gompertz on his willingness to take risks and it was stated that the ventures had made a difference to how Tate is perceived externally.
- b. The exceptional development of Tate Britain under the leadership of Dr Stephen Deuchar was highlighted. Trustees congratulated Dr Deuchar on his leadership as the founding Director of Tate Britain, and in providing the gallery with a strong sense of purpose and an excellent exhibition programme, evidenced by the extraordinary growth of over 50% in annual visitors to Tate Britain, from 1.1 million to around 1.7 million.
- c. Trustees expressed their sincere gratitude to Anish Kapoor for the time he has served as a member of the Tate Board of Trustees. Trustees praised Anish in particular his distinctive ability to frame Tate's activities in terms of broader issues and ambitions. Anish stated that the effect Tate has had in opening up art to large numbers of people is visible even in other art institutions in the UK and that he is sad to leave Tate as a Trustee. Anish conveyed his passion for Tate Britain, and his ambition for the gallery to continue to carve out a distinctive identity. Anish also emphasised the importance of intimate collaborations with artists, and encouraged Tate to continue to develop its relationships and work with artists.
